Thank you for your reply. I am sorry to hear you are unwell and I do hope that you receive adequate care and support, unlike the care and support provided to my brother.

Niceties aside, I note your registration as a solicitor states your legal qualifications are in the field of expertise of company and commercial, and not areas of care.

Although I am already aware of the two ICO web page links you kindly provided, my past research indicates they are just two of some 102 registered companies at that particular address. Can you please confirm which one of the two registrations you supplied relates to H House and The Data Protection register?

I would also like to know, who within your organisation has certified data protection controller training, including the GDPR?

I believe you will find I responded to your email of 21st October (attached as "Subject Access Request - including missing care plan 23rd October.pdf"), please check your record for verification.

Although, I am not currently my brother's litigation friend due to a possible conflict of interest I shall be seeking separate prospective legal proceedings, and will at the appropriate time also pass some new information on to my brother's solicitor.

Having checked both data protection registrations entries, I note it state where necessary or required we share information with family, associates and representatives of the person whose personal data we are processing. Therefore I would like to apply for separate subject access request, with a similar list of data as previous requested, due to prospective legal proceedings.

Please add to my separate data request your colleague's name S H and any communication including email that contains the name s h @priorygroup.com and my personal data, as I note they are included in an email from Ms S on 9th November 2016.

Lastly, I make you aware that, to date, I have not received my brother's full care plan as promised. I would also like you to note the attached document named "Home Support Plan 23-09-2016 Page 1.pdf."
